# ITEM 2.3 CONFIDENTIALITY MOTION TO REMAIN IN CONFIDENCE FOR 2.2 SANTOS TOUR DOWN UNDER 2024

#### That:

- 1. Pursuant to section 91(7) of the Local Government Act 1999 the Council orders that the following document(s) relating to Agenda Item 2.2 Santos Tour Down Under 2024, shall be kept confidential, being document(s) relating to a matter dealt with by the Council on a confidential basis under sections 90(2) and 90(3)(b)(i) and (d)(i).

  - information the disclosure of which would divulge information provided on a confidential basis by or to a Minister of the Crown, or another public authority or official (not being an employee of the Council, or a person engaged by the Council)
  - commercial information of a confidential nature (not being a trade secret) the disclosure of which could reasonably be expected to prejudice the commercial position of the person who supplied the information, or to confer a commercial advantage on a third party.
- 2. This order shall operate:
  - For a period of 3 months; or
  - Until the execution of a contract.

and be reviewed every 12 months (if the confidentiality period is longer than 12 months in duration)

3. Pursuant to section 91(9)(c) of the *Local Government Act 1999*, the Council delegates to the Chief Executive Officer the power to revoke this order in whole or in part.
